✓SPREP has been a driving force towards significantly increased financial and human resources for the environment of Pacific countries







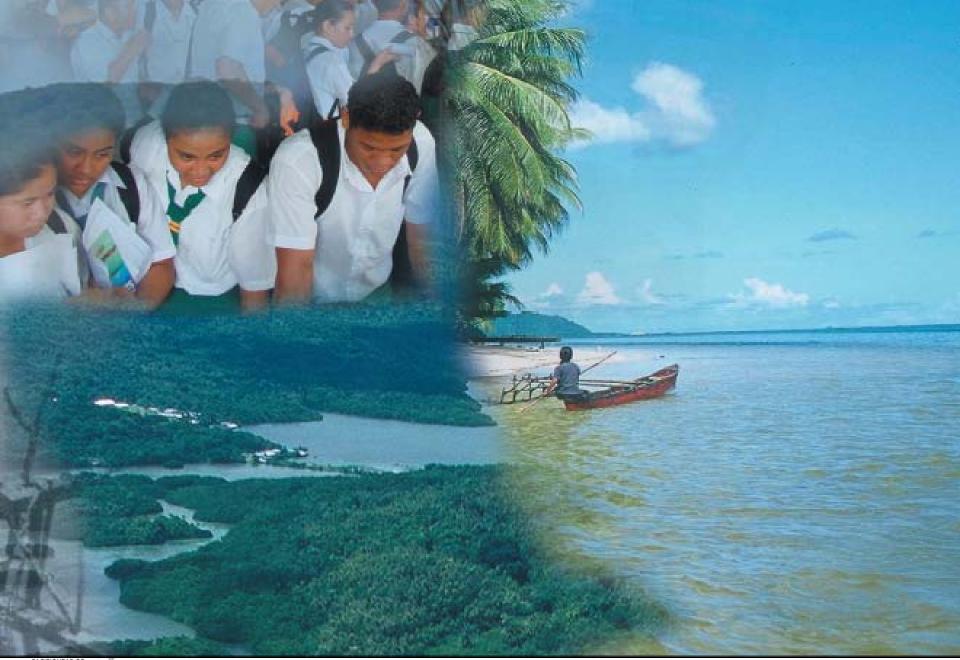
Key 2016 Review Findings

 Environmental Management is fully mainstreamed into development sectors in all PICTs

✓ Biodiversity Conservation is recognized and used as a key front line defense strategy for addressing Climate Change











Key 2016 Review Findings

✓SPREP Management of all human and financial resources conforms to world best practice standards

✓SPREP staff are motivated and enjoy their work. SPREP attracts and retains the highest quality of staff.







Key 2016 Review Findings

✓ Donors recognize that any funds invested in SPREP will deliver tangible and sustainable benefits for PICTs. Funding has shifted from short term project to longer term programmatic funding. All Member Countries have paid their dues and indeed all have contributed additional voluntary funding



✓ Donors and partners see SPREP as a reliable and trusted organisation to work with





How to achieve this future vision?

Together – working as a team – SPREP Members, SPREP staff and partners. If there are issues we address them openly and together



 Through a strategic approach – based on a visionary Strategic
 Plan, developed through open and effective consultation with SPREP Members







How to achieve this future vision?

Key elements of a strategic approach:

(a) shift from short term, activity focussed outputs to longer term strategic programmes and outcomes

(b) focussing on priorities – including saying no to some requests and demands



(c) learning from experience, including past reviews such as the ICR

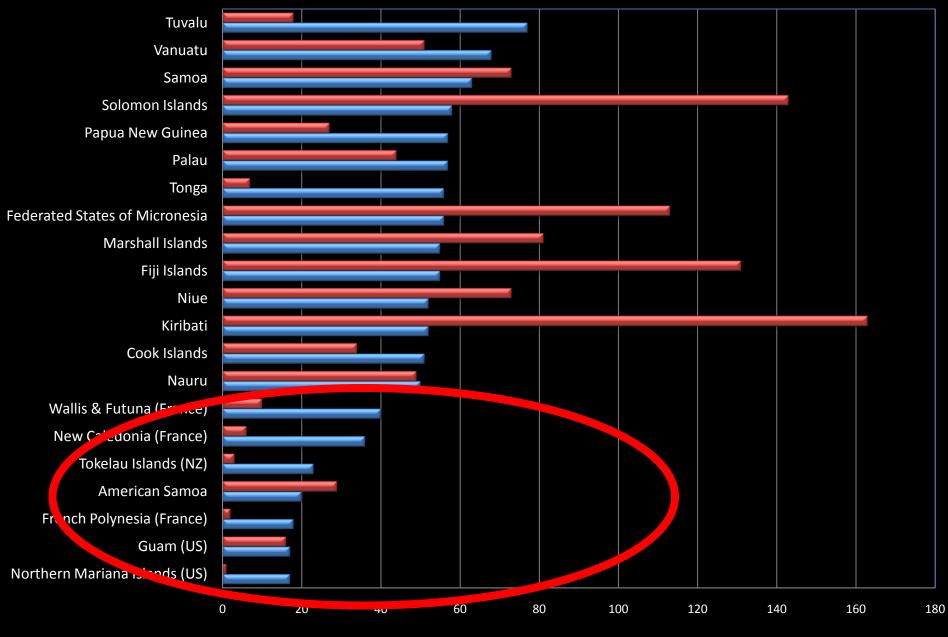
How to achieve this future vision?

How to achieve this future vision?

Ensure work on Climate Change is effectively integrated within SPREP and is supporting identified PICT needs and efforts to address Climate Change

✓ Maintain SPREP's work at the policy level but ensure it is based on science and practical, field based projects in PICTs.







How to achieve this future vision?

 Ensure that finance and human resource processes are working as effectively as possibly – we should aim for world best practice standards

 Ensure effective management decision making – which is openly communicated to SPREP staff and Members

 Ensure Member Country and Territory ownership of SPREP Programmes is improved

 Work more effectively with partners
 work closely with donors as partners to ensure their long term confidence

2010 Workplan and Budget

✓The 2010 Workplan document outlines Outputs, Indicators and Activities

The format used for the Workplan and Budget has been revised from previous years and now follows the format used by other key CROP agencies, including SPC and PIFS





2010 Workplan and Budget

 The Secretariat proposes a balanced budget of \$USD
 10,416,658, comprising \$2,403,705 of core funds and \$8,012,953 of programme funding

✓The budget provides for the cost of proposed salary adjustments discussed at the 19th SM







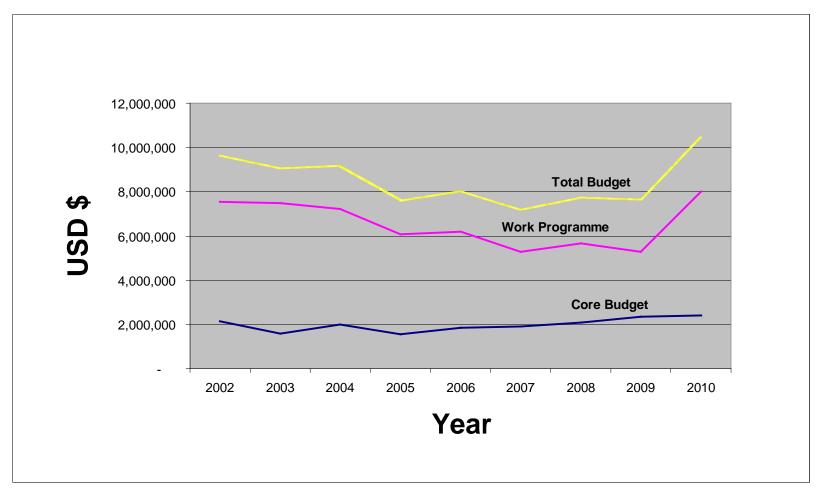
2010 Workplan and Budget

The budget covers: (A) Core budget which is funded by Member Contributions, programme management fees and other misc funding; and (B) Work Programme which is funded by donor contributions

 ✓ The 2010 budget has increased by 36% from the 2009 budget

A balanced budget is presented for consideration by the SPREP Meeting
